# Nature Based Solutions Manager

**Main function of post:** to lead on the delivery of NBS interventions in two Defra Flood and Coast Resilience & Innovation (FCRIP) partnership projects in Slough (Project Sponge) and Richmond, London (Community Bluescapes)

Supervisory responsibilities: No line management responsibilities

## Responsibilities of the post

- 1. To lead on the delivery of NBS interventions to enhance climate change resilience in priority neighbourhoods with the WWT team and local people.
- Where necessary, manage the planning application process for the NBS interventions, working with our partners, the local planning authorities to ensure smooth progression through the planning system.
- 3. To manage tendering and contract management processes (including financial management) as required to deliver NBS interventions effectively and to the highest standard.
- 4. To assist with the installation of NBS interventions with contractors and/or volunteers.
- 5. To assist with the design and delivery of the monitoring of NBS interventions.
- 6. To effectively communicate messages about flooding, climate change and nature-based solutions to local communities, partners and stakeholders.
- 7. To cultivate new relationships with local individuals, organisations and businesses to enhance WWT's project delivery.
- 8. Where appropriate and agreed with other partners, to support the delivery of the broader partnership aims and objectives and work constructively across the two partnerships to ensure good working relationships and maximise the opportunities for delivery.
- 9. To ensure all action activities are delivered safely and securely; that people are able to fully participate and have an enjoyable experience.

- 10. To assist with evaluation of the impacts of all WWT activities undertaken as part of the project
- 11. To work as part of a multi-discipline team including PhD students and scientists within WWT but also to engage effectively with the formal programme partnerships.
- 12. To work alongside volunteers encouraging, developing and supporting them in their work for WWT, ensuring that they have a positive volunteering experience.
- 13. To be responsible for working within the WWT health and safety and safeguarding policies and guidelines ensuring that the health, safety and wellbeing of yourself and others is an integral part of how you work. Where appropriate to ensure same for working within the two partnerships.
- 14. To be responsible for engaging with the WWT Sustainability Statement, being aware of negative environmental impacts and incorporating sustainable ways of working within your role.
- 15. To ensure that in the course of your work you adhere to the WWT Data Protection policy and standards and those of the two partnerships.
